8. Recognize the fiduciary nature of the relationship between the public, with whom I deal, other members of the Association, and myself as a result of the trust and reliance others place upon me

This Code of Ethics for the members of the HBA has been adopted to promote and maintain the highest of standards of service and personal conduct among its members. Our Code of Ethics applies to you personally and therefore applies to any company with which you are involved in conducting business in the home building industry. The HBA holds members to a higher standard and is serious in the enforcement of this Code. Adherence to these standards is required for membership in the Association, and serves to assure confidence in the integrity of the Association and its members. Members also agree as a condition of membership, to participate when requested in any proceedings of the Ethics and Grievances Committee and to abide by any decision of the Committee resulting from such proceedings.

I understand it may require 30 days minimum for this application to be checked with the screening committee. By my signature below, I also give my permission for the HBA to send me faxes and e-mails in accordance to the FCC/FTC broadcast limitations act.

I understand that my signature on this application signifies that I have read the HBA Code of Ethics and agree to abide by the standards, rules and regulations, Code of Ethics, recommendations by the Ethics Committee, Articles of Incorporation, the By-Laws of the Home Builders Association, the National Association of Home Builders (NAHB), with which it is affiliated and the affiliated State Association. I understand that if the Builder/Associate Member fails to renew, my affiliate membership automatically lapses/cancels.

Membership in the HBA is a privilege. I understand that I may not be accepted or I can be terminated from membership, for cause, by a majority vote of the Board of Directors.
